

# JOB DESCRIPTION ADULT EDUCATION NAVIGATOR, FARMERSVILLE ADULT SCHOOL

## **DEFINITION:**

Under the general direction of the Farmersville Adult School Administrator, the Navigator will provide outreach and support services for the adult education program. This individual will coordinate adult education enrollment and articulation processes, participate in adult education recruitment efforts, and serve as the liaison to programs services for adult education candidates. This position is assigned to the adult education site(s) within Farmersville Unified. (Days 180)

# ESSENTIAL DUTIES:

- Plan, coordinate and conduct activities and programs to provide enrollment, orientation and transition assistance to prospective adult education students.
- Develop recruitment strategies and coordinate the development of promotional materials such as brochures, speeches, videos, posters and newsletters for use with prospective students and partner organizations.
- Cooperate with the adult education administrator in developing, coordinating and implementing various social media marketing strategies to accelerate student engagements.
- Design and deliver oral presentation and workshops for adult education student candidates to include panel presentations, group presentations, and one-on-one meetings.
- Coordinate outreach efforts with counselors and faculty at other adult education service providers and support service partners to develop a referral system, exchange information, and provide quality outreach for prospective students.
- Coordinate events, workshops and seminars with partner organizations in Tulare and Kings Counties for prospective students.
- Assist in facilitating collaboration between adult school and community college faculty.
- Direct high school students to the appropriate career pathways and other adult education services relevant to their interests.
- Participate in relevant advisory committee meetings.
- Initiate and maintain positive relations with other school administrators, counselors, faculty and with public agencies and community groups to develop recruitment sources.
- Schedule campus visits for prospective students.
- Keep abreast of educational and student support programs to provide accurate and timely information to adult education students, staff, and partner organizations.

- Maintain a variety of records, logs, and student files including those of a confidential nature; prepare periodic and special reports and statistical data related to program activities and effectiveness
- Maintain a variety of data and statistical reports regarding adult education examination data to align outreach activities and their effectiveness, including coordinating pre/post examinations, survey outreach and data analysis.
- Perform other related duties as assigned.

- Proficient with computer applications and software applications and programs.
- Must possess a valid California Driver's License.

- Bi-lingual in English and Spanish preferred.
