If a general public comment or comment on a business item is received after 3:00 p.m., efforts will be made to read your comment into the record. However, staff cannot guarantee that written comments received after 3:00 p.m. will be read. All written comments that are not read in the record will be made part of the meeting minutes, provided that such comments are received prior to the end of the District Board meeting.
