The Board of Education of Farmersville Unified School District invites highly qualified educational leaders to apply for the position of District Superintendent. The District Superintendent will oversee Curriculum and Instruction.

SELECTION PROCESS

The Board of Education has retained Consultants Juan Garza and Blanca G. Cavazos, Ed.D. of Leadership Associates to recruit qualified candidates. The consultants will screen applications and recommend candidates to the Board for interviews and further consideration. The Board will have the opportunity to review all applications submitted. Any contact with Board members, in an attempt to influence the selection process, will be considered a breach of professional ethics. Finalists will have an opportunity to familiarize themselves with the community and schools. Board members reserve the right to visit the District and communities of a candidate prior to a final decision.

SALARY AND CONTRACT

The salary range is \$189,000-\$212,000, based upon qualifications and experience. A multiyear contract will be considered.

To be considered, the candidate must provide:

- Three letters of recommendation
- Five professional references
- Verification of degrees and credentials (finalists only)

THE DISTRICT

Farmersville Unified School District serves approximately 2,500 students in grades TK-12. The District is located in the City of Farmersville which is a rural agricultural community of approximately 10,000 residents in the Central Valley. District schools include three

elementary schools, junior high school, high school, continuation high school, and adult school. The District employs 280 employees and has a General Fund budget of approximately 30 million dollars. The ethnic composition of the District student population is 96% Hispanic, 2% White, and 2% are designated as two or more races. The student subgroup population includes 95% are designated as socio-economically disadvantaged, 36% are designated as English Learners, and the District's unduplicated student percent is 94.6% (English Learners, Low Income, and foster youth).

The vision of the Farmersville Unified School District is "Preparing students to be productive members of society and innovative leaders of tomorrow. Students will be equipped with the necessary skills and tools to be post-secondary prepared, and they will be highly qualified to compete in the global economy." FUSD's district objective is to work collaboratively with all stakeholders to provide a rigorous and engaging course of study for all students. In addition to high-quality curriculum programs, the District will continuously assess student learning and outcomes; and provide researched-based and systematic student interventions to help close the student achievement gap for all students.

THE COMMUNITY

The City of Farmersville is located in Tulare County, California, in the heart of central California and at the base of the Sierra Nevada mountain range, home to Sequoia National Park and Forest, with Los Angeles 200 miles to the south and the Bay Area 225 miles to the north. Located in the great central California region, comprised of more than 3.4 million residents, the region has a rapidly growing population that is young and culturally diverse.
