Rachel Mendez, Hester School Principal, recognized Mario Hernandez, Grade 1 student, and his parents. He was the youngest selected out of all the other students. Janet Jones, Acting Superintendent, stated Mario was also recognized by the Tulare County Board of Supervisors. Mrs. Mendez stated Mario was awarded a \$25.00 check from the Tulare County Board of Supervisors.

Brent Calvin, College of the Sequoias, made a PowerPoint presentation regarding enrollment of first-time students (fall terms); course load of first-time students (fall terms); educational programs of first-time students; English: college-level placement of first-time students; Math: college-level placement of first time students; success rates of first-time students (fall terms); Fall-to-Fall persistence of first-time students; and degrees/certificates awarded to all students. Earl Mann, COS representative, was also present.

Freddy Valencia, Student Board Member, made an oral report to the Board regarding FHS activities.

Alice Lopez, community member, stated "I just had a question on that because you guys know that I'm a big proponent of advancing on our Ag department and I've always wanted them to keep on improving but now we're working off of bond money and I'm not sure that because the hog pens fell apart that that should come out of bond money. I think we're lucky it came apart now rather than when we have these hogs moving around in there and I really do think that money should come out of some other budget other than the bond. I'm not sure that's what the people voted for to spend money like that on the hog pens."

PUBLIC COMMENTS (8.0)

Billie Shawl, Farmersville Community for Child Well Being, stated "it's a project for Tulare County Child Abuse and Prevention Council. I came tonight to invite you personally to the culmination of 4 years of community building. We are going to dedicate a children's bench in front of the white church on Thursday, April 28th at 3:30 p.m. The children's bench is dedicated to the well being of all children and we know that everybody who works in education is concerned about children's well being. This will be a symbol for Farmersville but also we think a symbol for Tulare County, maybe the State of California and maybe the nation because we don't think it's been done anywhere else." Mrs. Shawl also stated "April is National Blue Ribbon Child Abuse Prevention Awareness month."

The student shall be allowed to return to school immediately. The members of the panel recommended a change in classroom environment, and continued support from the District's School Psychologist.
