

# Farmersville Unified Nutrition Services Special Dietary Needs Procedure Revised School Year 2024-25

## Overview

The Americans with Disabilities Act (ADA) Amendments Act made important changes to the meaning and interpretation of the term "disability". In September 2016 these updates were issued to USDA school meal programs. The ADA Amendments Act simplified the question of whether a child has a disability by requiring a broad interpretation of what constitutes a disability. Under the ADA, anything that substantially limits a major life activity (most physical and mental impairments) constitutes a disability. This includes conditions that impair immune, digestive, neurological, and bowel functions, as well as many others. Schools shall focus on what can be done in order to ensure equal opportunity for all children to participate in school meal programs.

The process of providing modified meals for children with disabilities shall be as inclusive as possible. The school shall work collaboratively with parents and guardians to ensure children receive a safe meal and have an equal opportunity to participate in the school meal programs. The nutrition department shall use a team approach that includes parents and guardians and (as age-appropriate) the child, when providing modified meals.

### Accommodating Children with a Disability

**Farmersville Unified Nutrition Services** will provide food substitutions to a child with a disability when the need for a substitution is supported by a written medical statement or completed <u>CDE medical</u> <u>statement form</u> that is signed by a licensed physician, a physician assistant, or a nurse practitioner.

According to the ADA, most physical and mental impairments will constitute a disability. This includes conditions that impair immune, digestive, neurological, and bowel functions, as well as many others. General health concerns, such as a parent's preference that a child eat a gluten-free diet because the parent believes it is healthier for the child, are not disabilities and do not require a modification. All disability considerations must be viewed on a case-by-case basis.



### **Guidelines for Handling Medical Statements and Special Diet Meals:**

## 1. Submission of Medical Statements:

All Medical Statement to Request Special Meals and/or Accommodations related to student dietary need for meal accommodations that do not meet program meal patterns must be submitted to Farmersville Nutrition Services Clerk, Cathy Ibarra, via email @

### 2. Storage of Medical Statements:

Once received, Mrs. Ibarra will distribute a copy of the medical statement, which will be securely stored in a **RED binder** at each school cafeteria site. This binder is only accessible to FUSD Nutrition Services personnel.

## 3. Daily Check by Staff:

FUSD personnel, sites Cooks and ASP FWSI (After School Program Food Workers), must check the RED binder **before every meal service** to ensure they are aware of any special diet requirements and can accommodate students accordingly.

## 4. Handling High-Priority Diet Meals:

High-priority diet meal substitutions will be managed carefully by the Director of Food Services in coordination with the Food service manager and the High School Central Kitchen Cooks. Together, they will ensure that all specific dietary needs are addressed and that meals are delivered to the appropriate sites as needed.

### Recordkeeping

In addition, special meal accommodation made by cafeteria staff shall be documented in the daily menu production records as part of the record of meals served to students.to receive reimbursement for meals served to children with disabilities that do **not** meet Program meal pattern requirements, the written medical statement must identify/include the following details:

- Information about the child's physical or mental impairment is sufficient to allow the SFA to understand how it restricts the child's diet.
- <u>An explanation of what must be done to accommodate the child; and</u> the food or foods to be omitted and recommended alternatives, if appropriate.

Medical statements are not required to be updated on an annual basis. However, when **Farmersville Unified Nutrition Services** does receive updated medical information, those updates must be reflected in the medical accommodations. If medical accommodation is no longer required, the school will maintain a record of the request to end the medical accommodation, such as a copy of an email from the parent stating the child no longer needs a meal accommodation.

### Accommodating Children without a Disability



**Farmersville Unified Nutrition Services** is not required but will attempt to provide food substitutions to a child with a special dietary preference that is not considered a disability. An individual who does not have a disability but cannot consume a particular food because of a non-disability reason, such as religious or moral reasons, is considered to have a food preference. All meals served to students with a food preference **must** meet USDA meal pattern requirements to qualify for reimbursement. This accommodation will be considered on a case-by-case basis.

## **Non-Discrimination Statement**
